# 6. NEW PLANNING APPLICATIONS

The Committee considered the following planning applications in respect of which Bath & North East Somerset (B&NES) Council had invited comments:

**15/04392/FUL** - 3 Beech Road - Erection of two storey side extension (Resubmission of 15/01056/FUL) - Mr C Harvie

It was resolved that B&NES Council be advised this Council **COMMENTS ON** this application: No objection.

**15/04444/FUL** - The Folly, The Folly - Erection of a single storey rear extension, extension of roof to allow for loft conversion, erection of two double garages: Division of existing single dwelling into two dwellings - C & C Sumner & Warner

It was resolved that B&NES Council be advised this Council **COMMENTS ON** this application: We see the positive benefits of an additional dwelling for the village, but we ask you to be mindful of the Highways report and its implications, and the depth and proximity of the sewer.

#### 7. WEST OF ENGLAND JOINT SPATIAL PLAN ISSUES AND OPTIONS ENGAGEMENT

The Committee initially considered the West of England Joint Spatial Plan 'Issues and Options' engagement, which will run for 12 weeks from 9 November 2015 until 31 January 2016. Members of the Committee noted that Saltford is mentioned in the draft 'Issues and Options' document as a possible strategic location for additional housing. Members are to send their comments to the Clerk for collation, and a recommendation for the Parish Council's response to the consultation is to be brought to the January Parish Council meeting.

15/03963/FUL - 468 Bath Road - Erection of single storey rear extension following demolition of existing conservatory - Miss Marie Lillingston
