1. MINUTES

8. POSSIBLE CONTRAVENTIONS

The Clerk reported the following updates from B&NES on possible contraventions of planning controls:

08/00651, 11/00366, 11/00513 & 14/00992/UNAUTH - Because of the subsequent additional complaints about the moorings, the two case officers involved have had to compare investigations in order to any avoid duplication. This means that before any PCNs can be served or other conclusions reached the officers will need to check that there has been no change in circumstances since the last visit and ensure there is a consistency and co-ordination in approach. With regard to the request for the Parish Council to have copies of the PCNs, under the provisions of the Data Protection Act we are unable to provide copies of the completed PCNs as these are likely to contain confidential information which would not be appropriate in the public domain. As with all Enforcement investigations, at the investigatory stage the information we hold is confidential as any disclosure could prejudice our position. It is usual that only Enforcement Reports (making recommendations) and Enforcement Notices would be public documents; in this case once a report has been finalised (which will take into account any information presented in the PCN), and in the event that a Notice is served, the Council will be able to provide the Parish Council with copies of both.

The Committee requested that the following possible new contravention be reported to B&NES:

Entrance to The Riverside Inn - Large new advertising sign on fence.
